**ARTICLES OF ORGANIZATION  
OF  
RICHARD STREET LC**

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, adopts the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company is Richard Street LC.

**ARTICLE II**

**ADDRESS**

**ARTICLE III**

### MEMBERS' RIGHTS TO CONTINUE BUSINESS

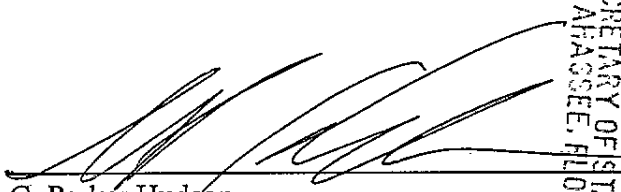
