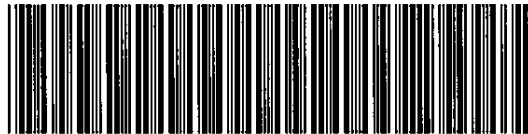


AFFIDAVIT
