**ARTICLES OF ORGANIZATION  
OF ESEMVESTS, L.L.C.**

The undersigned, acting as organizer and authorized representative of a member of ESEMVESTS, L.L.C., under Section 608.407 of the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization:

**ARTICLE I -- Name:**

The management of the Company is reserved to its Members.


**ARTICLE VII — Purpose and Powers:**


