## ARTICLES OF ORGANIZATION OF CAPE CORAL TITLE SOUTH, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be Cape Coral Title South, L.L.C. ("Company")

#### ARTICLE II - ADDRESS

The mailing address and street address of the principle office of the company is 4825 #2 Coronado Parkway, Cape Coral, Florida, 33904.

#### ARTICLE III - DURATION

The company shall commence its existence on the date these Articles Of Organization are filed by the Florida Department of State or on another date if specified. The company's existence shall be for a period of twenty years from the date hereof unless the company is dissolved earlier as provided by these Articles Of Organization or by regulations adopted by the company.

#### ARTICLE IV - REGISTERED OFFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is Richard D. Lakeman, P.A., 3636 Del Prado Blvd., Cape Coral, Florida, 33904.

#### ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

#### ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members or as is otherwise provided in the company's operating agreement and not prohibited by Florida law.

#### ARTICLE VII – ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her

interest in the company or portion thereof as provided in the regulations of the company and as set forth in the company's operating agreement, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member and such transferee's interest shall be a non-voting interest.

#### ARTICLE VIII - MEMBERS RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager or on the unanimous written agreement of all members or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a vote of the remaining members in accordance with the company's operating agreement and in accordance with Florida Law.

#### ARTICLE IX - MANAGEMENT

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles Of Organization.
