ARTICLES OF ORGANIZATION OF

The principal office of this limited liability company shall be located at 164 Blue Lupine Way, Santa Rosa Beach, Florida 32459.

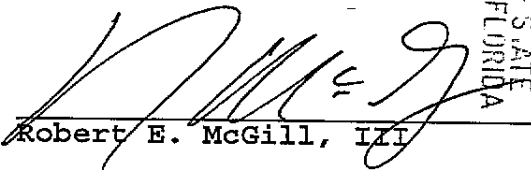
