**ARTICLES OF ORGANIZATION OF
LUENCA, LLC**

**ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be LUENCA, LLC, and the mailing address and street address of its principal office shall be 3508 Tamiami Trail, Port Charlotte, FL 33952, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.


