**ARTICLES OF ORGANIZATION  
FOR  
METROWEST PLACE II, L.L.C.**

**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned acting as the organizer of Metrowest Place II, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is METROWEST PLACE II, L.L.C.

**ARTICLE II  
PURPOSE AND POWERS**

A. Purposes. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.
