ARTICLES OF ORGANIZATION OF *SERVITEC, LLC*

The undersigned, desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be the *SERVITEC, LLC.* and the mailing address and the street address of the principal office of the limited liability company shall be *EINAR VIVAS IZQUIERDO 1531 Estancia Circle, Fort Lauderdale, Florida 33327-9999*

SECOND: *SERVITEC, LLC.*, shall have a perpetual duration from the date of the filing of these Articles of Organization.

THIRD: Copies of the operating agreement and bylaws of the *SERVITEC, LLC.* may be obtained from the Managing Member via a written request mailed to *EINAR VIVAS IZQUIERDO, 1531 Estancia Circle, Fort Lauderdale, Florida 33327-9999*, which is the place in the State of Florida where the principal office of the company is located.

FOURTH: The purposes for which the *SERVITEC, LLC* is formed are:

- (A) to represent purchase and develop a business enterprise in the State of Florida;
- (B) to engage in such other lawful acts or activities for which limited liability companies may be formed under Chapter 608 of the Statutes of the State of Florida.

FIFTH: The maximum number of ownership units which *SERVITEC, LLC* is authorized to have outstanding is one hundred (100), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator.
