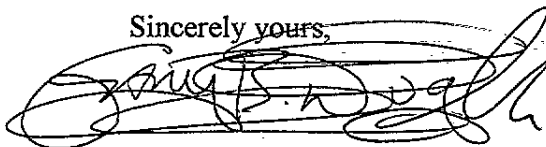

PlanetRadio, LLC**

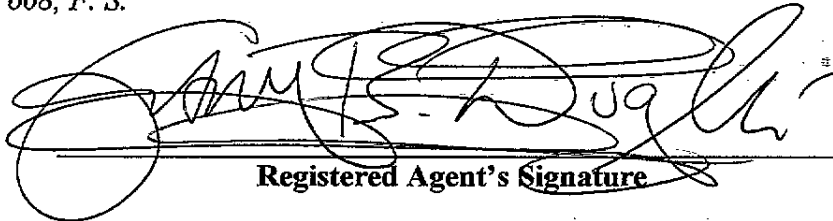

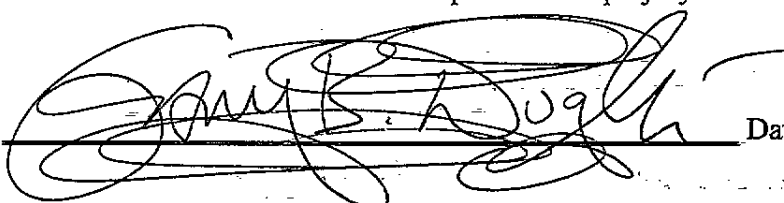
