WHEREAS, the Articles of Organization of FREEDOM WARRIORSUSA, LLC were filed with and approved by the Secretary of State of the State of Florida on the 22nd day of August, 2001;

WHEREAS, the First Amendment to Articles of Organization of FREEDOM WARRIORSUSA, LLC were filed with and approved by the Secretary of State of the State of Florida on the 13<sup>th</sup> day of September, 2002 changing the name of the company to NEHEMIAH USA NETWORK, LLC;

WHEREAS, it is the intention of the sole member and the sole manager of NEHEMIAH USA NETWORK, LLC that the Articles of Organization of NEHEMIAH USA NETWORK, LLC be amended in accordance with the proposed amendment hereinafter set forth;

WHEREAS, the proposed amendment hereinafter set forth was approved by the sole member and the sole manager on the 17th day of September, 2002; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Organization of NEHEMIAH USA NETWORK, LLC are hereby amended by adding a new Article II - NAME as follows, to-wit:

"ARTICLE II  
NAME
