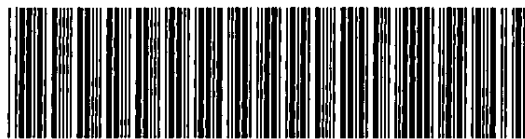

EIGHTH AMENDMENT TO  
ARTICLES OF ORGANIZATION
