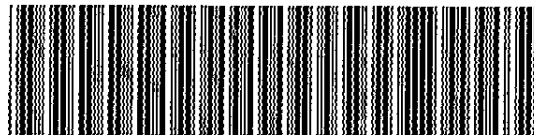

FOURTH AMENDMENT TO
