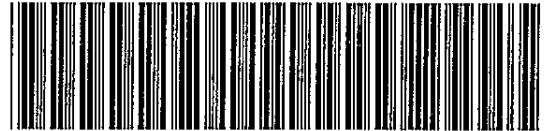

FIFTH AMENDMENT TO
ARTICLES OF ORGANIZATION

WHEREAS, the Articles of Organization of FREEDOM WARRIORSUSA, LLC were filed with and approved by the Secretary of State of the State of Florida on the 22nd day of August, 2001;

WHEREAS, the Fourth Amendment to Articles of Organization adding Article II – NAME were filed and approved by the Secretary of State of the State of Florida on the 07th day of August, 2003 changing the name of the company to I STAND READY AMERICA, LLC;
