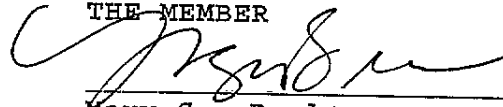
ARTICLE VI.

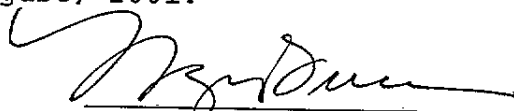
