The name and address of the limited liability company's registered agent is John Reimler, 8802 Corporate Square Court, Jacksonville, Florida 32216.

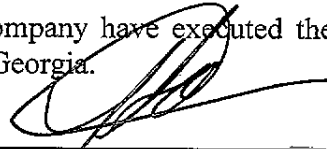
