# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF ORBINET USA, L.L.C.

The undersigned hereby Amends and Restates the Articles of Organization of Orbine USA, L.L.C., a Florida limited liability company pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act") which were filed with Florida Secretary of State on August 23, 2001.

#### **ARTICLE ONE**

#### **NAME**

# ADMISSION OF ADDITIONAL MEMBERS AND TRANSFER OF MEMBER INTEREST

# **ARTICLE EIGHT**

# WITHDRAWAL, RETIREMENT, DEATH BANKRUPTCY OR EXPULSION

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member, this limited liability company shall be dissolved; provided that the members other than the deceased, retired, resigned, or expelled member, may consent to continue the business of this limited liability company, or by amendment to these Articles of Organization may provide for the continued existence of this limited liability subsequent to the foregoing events, subject to distribution to the former member, his heirs and successors of assets as provided in dissolution.

#### ARTICLE NINE

To the fullest extent permitted by law, the Company shall indemnify any person who was or is a party to any proceeding by reason of the fact that he/she is or was a manager or a managing member of the Company or is or was serving at the request of the Company as a manager, managing member, officer, employee or agent of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in connection with such proceeding, including the appeal thereof, if he/she acted in good faith and in a manner he/she reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct

was unlawful. The limited liability company shall reimburse each person for all costs and expenses, including attorneys' fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the operating agreement of the limited liability company.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
