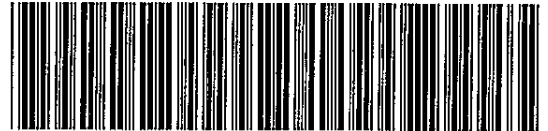



**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
JASMEN OF PENSACOLA, L.L.C.**

FIRST: The date of filing of the Articles of Organization of Jasmen of Pensacola, L.L.C. (the "Company") was August 23, 2001.

SECOND: The following amendments to the Articles of Organization were adopted by the Company:

A. Article Three, subparagraph (a), is amended to provide as follows:
