ARTICLE XI - AMENDMENT OF ARTICLES OF ORGANIZATION

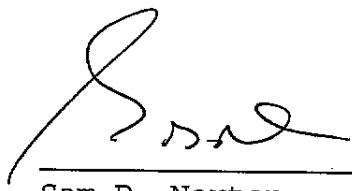

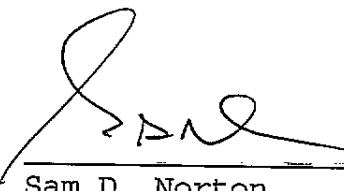
ACCEPTANCE OF REGISTERED AGENT
