## ARTICLES OF ORGANIZATION OF The VeriCom Group, LLC

ARTICLE I

Name of Company

The VeriCom Group, LLC

ARTICLE II
Business of Organization

The limited liability company may engage in the business of providing communication verification services and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE III Principal Place of Business
