#### ARTICLE I

#### <u>NAME</u>

The name of the limited liability company is HAIRCOLORXPRESS DEVELOPMENT OF SOUTHWEST FLORIDA, LLC (the "Company").

ARTICLE II

#### ARTICLE VII

#### MANAGEMENT

The Company is to be managed by its managing member and is, therefore, a manager - managed Company. This Company shall initially have one manager. #### ARTICLE VIII

#### ADMISSION OF NEW MEMBERS

The then existing members of the Company shall have the right to admit new members. Additional members may be admitted only by the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

#### ARTICLE IX

#### **CONTINUATION OF BUSINESS**

The remaining members of the Company may not continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company unless there is unanimous written consent by the remaining members to do so.

#### ADDITIONAL PROVISIONS

The power to adopt, alter, amend, or repeal any provision contained in these Articles of Organization or the Regulations of the Company is vested entirely in the managing member listed above in Article VI herein, and only by written consent, in accordance with the Florida Limited Liability Company Act.
