ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

of

YEGELWEL, REISER & DIAZ, L.L.C.

FIRST: The date of filing of the articles of organization was August 24, 2001.

SECOND: The following amendments to the articles of organization were adopted by the limited liability company:

- (a) ARTICLE I is deleted in its entirety and replaced with the following new material:

“ARTICLE I – Name

The name of the limited liability company shall be Yegelwel, Reiser & Diaz, P.L.”

- (b) A new ARTICLE VI is added as follows:

“ARTICLE VI – Practice of Law

- (a) This limited liability company is organized to conduct the practice of law in the State of Florida pursuant to Chapter 621, Florida Statutes, and it shall comply in all with respects with that Chapter in its operating agreement and in the conduct of its business. It shall conduct no business other than the practice of law. It shall render legal services only through its members, officers, employees and agents who are authorized to practice law in the State of Florida.
- (b) No present or future member may be a person other than an individual or Florida entity duly licensed and authorized to practice law in the State of Florida.
- (c) If any member, officer, agent, or employee of this limited liability company who has been rendering professional service to the public becomes legally disqualified to render such professional services within this state or accepts employment that, pursuant to existing law, places restrictions or limitations upon that person's continued rendering of such professional services, that person shall sever all
