**AMENDMENT TO

**ARTICLE IV - Management**





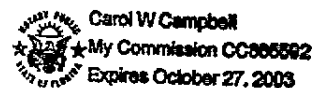
