Pursuant to the provisions of Section 608.411, Florida Statutes, Signet Healthcorp, LLC, a Florida limited liability company, does hereby adopt the following amendment to its Articles of Organization:

FIRST: The Articles of Organization of Signet Healthcorp, LLC, formerly known as Maps Acquisitions, LLC, were filed on August 28, 2001, and assigned Document Number L01000014622.

SECOND: Article I of the Articles of Organization is hereby amended to read as follows:
