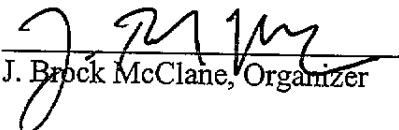
**Articles of Organization**

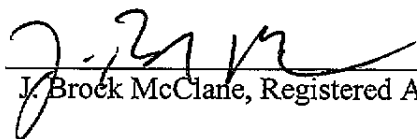
