1. **NAME.** The name of the Limited Liability Company shall be Swiss Products Distributing, LLC, a Florida Limited Liability Company.

5. **INITIAL REGISTERED AGENT.** The name and street address of the initial registered agent of the Limited Liability Company is:



manager, officer, employee and/or agent derived an improper personal benefit. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such member, member manager, officer, employee and/or agent may be entitled.

7. **EFFECTIVE DATE.** The Limited Liability Company's existence shall commence at the date and time when these Articles of Organization are filed.




