ARTICLES OF ORGANIZATION OF**CRAZY TOO - SUNSET, L.L.C.**

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby forms a Florida limited liability company (this "Company") pursuant to the Act and hereby sets forth the following Articles of Organization (these "Articles"):

**ARTICLE I
NAME**

The name of the Company shall be: Crazy Too - Sunset, L.L.C.

**ARTICLE II
ADDRESS**

The mailing and street address of the Company's principal office is 2702 N. Dale Mabry Highway, Tampa, FL 33607.

**ARTICLE III
DURATION**

The period of duration for the Company is perpetual.

**ARTICLE IV
REGISTERED AGENT AND OFFICE**

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.


