**ARTICLE I
NAME**

The name of this Limited Liability Company shall be Goldstar Research & Development, LLC, and its principal place of business shall be located at 7746 Sugar Bend Drive, Orlando, FL 32819. The mailing address shall be: 7746 Sugar Bend Drive, Orlando, FL 32819.

**ARTICLE II
COMMENCEMENT OF CORPORATE EXISTENCE**

This Company shall exist for a period of thirty (30) years commencing on the date of filing of these Articles of Organization with the Florida Secretary of State, unless sooner dissolved according to law.

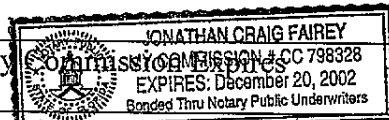
