**ARTICLES OF ORGANIZATION
OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this limited liability company is LA FUENTE INTERNATIONAL INVESTMENTS LLC (the "Company").
