ARTICLES OF ORGANIZATION OF LA FUENTE INTERNATIONAL INVESTMENTS LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME
