# ARTICLES OF ORGANIZATION COMPATIBLE SOFTWARE OF FL., LLC

The undersigned, organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

#### ARTICLE I

Name

The name of the Company is COMPATIBLE SOFTWARE OF FL., LLC.

#### ARTICLE II

#### Commencement Date and Duration

The Company's existence shall commence on the date these Articles are filed with the Florida Department of State, and shall continue perpetually until dissolved in accordance with Section 608.441 of the Act.

#### ARTICLE III

#### Purpose

The Company is created for purposes of engaging in any lawful activity deemed appropriate by the members from time to time.

#### ARTICLE IV

# Principal Office

The street address of the principal office of the Company shall be 3305 Lakeside Circle, Parrish, Florida 34219, and the mailing address shall be the same.

#### ARTICLE V

## Registered Agent and Office

The initial registered agent for the Company shall be ROBERT A. HEADLEE, and the address of the registered agent for service of process shall be 3305 Lakeside Circle, Parrish, Florida 34219.

#### ARTICLE VI

Management of Business

The Company shall be Member managed.

#### ARTICLE VII

## Admission of Additional Members

Additional Members may be admitted only by the affirmative vote of all of the other Members and upon terms and conditions established by the Members from time to time in their sole discretion.

#### ARTICLE VIII

#### Powers 1

The Company shall have all of the powers and authority set forth in Section 608.404 of the Act.

#### ARTICLE IX

#### Property

(a) Ownership. All property originally paid for or transferred to the Company as contributions to capital by the Members, or subsequently acquired by purchase or otherwise on account of the Company, shall be the property of the Company.

- (b) <u>Title</u>. The title to all property of the Company shall be held in the name of the Company.
- (c) <u>Conveyances.</u> The right and manner to convey and encumber title to all real and personal property of the Company shall be as specified in the Operating Agreement.

#### ARTICLE X

#### Amendments

These Articles may be amended or restated at any time by a unanimous vote of the Members of the Company, and such amendment or restatement shall be filed with the Floriday Department of State in accordance with the provisions of Section 608.411 of the Act.

#### ARTICLE XI

#### Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth in the Operating Agreement.

#### ARTICLE XII

#### Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of the Company except as may be specified in the Operating Agreement.
