ARTICLES OF ORGANIZATION OF INNOVATIVE PC'S, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

ARTICLE II - MAILING ADDRESS

ARTICLE III - DURATION

The period of duration for INNOVATIVE PC'S, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in INNOVATIVE PC'S, LLC, the remaining members may, by unanimous agreement, continue the business of INNOVATIVE PC'S, LLC.
