# ARTICLES OF ORGANIZATION OF ALL ABOUT BULBS, L.C.

A Florida Limited Liability Company

THE UNDERSIGNED, for the purpose of forming a Florida limited liability company under *Chapter*608, Florida Statutes, do hereby make and adopt the following Articles of Organization:

#### ARTICLE 1. NAME
