FIRST: The name of the Limited Liability Company is: PLANET FOOD, L.L.C.






FIFTH: The Limited Liability Company is to be managed by the Managing Members, who are: GIOCONDA MUIRRAGUI.

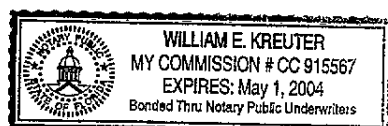




