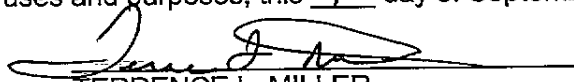
**ARTICLE 10 - MEMBERS**

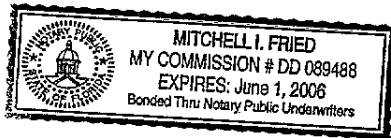
