The right, if given, of the Members to admit additional Members and the terms and conditions of the admissions shall be: With the consent of all Members.

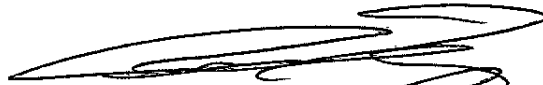
ARTICLE VI - Members' Rights to Continue Business:

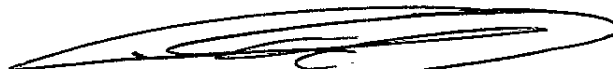
