


**ARTICLE 5



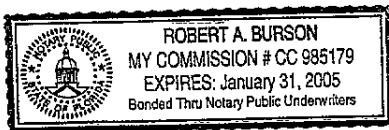
