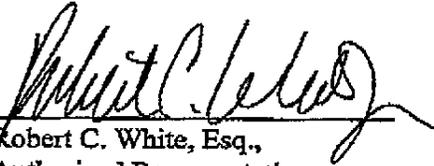
"ARTICLE I
