### ARTICLE VI. PURPOSES AND POWERS

The existing members shall determine the amount and nature of the contributions proposed by new members at the time those new members are admitted.

### **ARTICLE VIII. CONTINUATION OF BUSINESS**

The remaining members of International Financial & Legal Services, LLC have right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event, which terminates the continued membership of a member in the Company.
