### **ARTICLES OF ORGANIZATION**

The undersigned, acting as the members of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for HALFTRACK, L.L.C. (the "Company"):

#### **ARTICLE I**

# INITIAL REGISTERED OFFICE AND AGENT

# **MANAGEMENT**

The Company is to be managed by one or more managers and is, therefore, a manager - managed company.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, in accordance with Section 608.407(3), being the original member of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of HALFTRACK, L.L.C.
