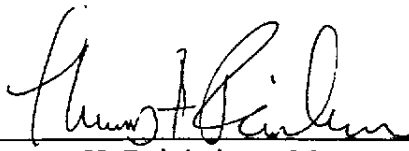
There are no suits or other proceedings pending against the Company in any court, or otherwise, and there has been no judgment, order or decree entered against the Company.

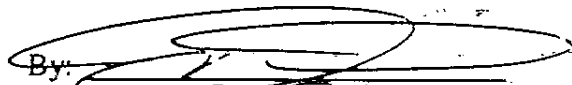

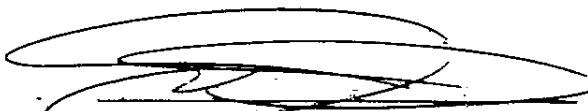
