## ARTICLES OF ORGANIZATION OF PARAMOUNT HOMES OF SOUTHWEST FLORIDA, LLC, a Florida Limited Liability Company

The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

#### ARTICLE I NAME

The name of the limited liability company (the "Company") shall be PARAMOUNT HOMES OF SOUTHWEST FLORIDA, LLC, a Florida limited liability company.

#### ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 4110 Enterprise Avenue, Suite 214, Naples, Florida 34104.

### ARTICLE III REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered agent of the Company is 4001 Tamiami Trail North, Suite 300, Naples, Florida 34103, and the name of the initial registered agent at such address is Scott M. Ketchum.

#### ARTICLE IV ADMISSION OF MEMBERS

The members of the Company may admit new members to the Company as more fully described in and subject to the terms, conditions and requirements set forth in the Company's Regulations. Newly admitted members shall have all of the rights and privileges as set forth in the Company's Regulations.

#### ARTICLE V EFFECTIVE DATE

The Company's effective date of existence shall begin on the date of filing of these Articles.

#### ARTICLE VI DURATION

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as provided in the Regulations.

#### ARTICLE VII ADOPTION OF REGULATIONS

The initial Regulations of the Company shall be adopted by its initial members. The Regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

#### ARTICLE VIII INITIAL MANAGERS

The Company will be managed by a manager or managers, who shall be designated, appointed or elected as more fully described in the Regulations. The initial number of managers of the Company shall be one (1). The number of managers may be decreased or increased in accordance with the terms of the Regulations.
