The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

ARTICLE 1 - NAME

The name of this company shall be MONKEY BOY TREE FARM, L.L.C.

ARTICLE II - PURPOSE

This company shall be authorized to undertake any lawful business or enterprise allowed by the Laws of the State of Florida and of the United States.
