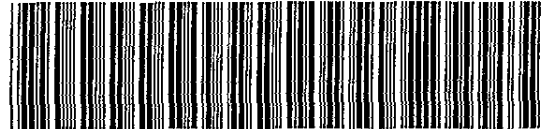

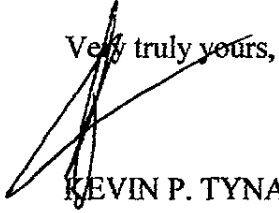

Article I: The Articles of Organization were filed on September 7, 2001.

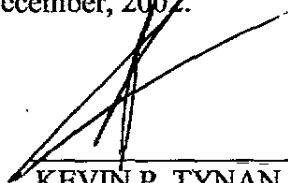
Article II: The following amendment to the articles of organization was adopted by Bowman, Richardson & Tynan, P.L.C.:
