

ARTICLES OF ORGANIZATION OF DESALINATION ENTERPRISES, LIMITED  
LIABILITY COMPANY

ARTICLE I—NAME

The name of the limited liability company shall be Desalination Enterprises, Limited Liability Company. The objectives and goals of Desalination Enterprises, Limited Liability Company, are

1. To perform studies/analyses of water requirements in specific countries/regions with particular emphasis and concentration in South East Europe.
2. To perform analyses of comparative benefits of different approaches to the water shortage problem, i.e., piping, diverting, collecting, solar stills, trucking/shipping, drilling, relocating, desalination.
3. To perform economic analyses to show short- and long-term cost-effectiveness of different approaches to the water shortage problem.
4. To analyze the economics of reverse osmosis vs. distillation of sea water.
5. To analyze the requirements of desalination plants for application to specific regions and localities.
6. To evaluate feed water resources of desalination plants for application to specific regions and localities.
7. To perform cost analyses of desalination plants.
8. To analyze desalination plant energy requirements and local energy resources.
9. To analyze water recovery requirements.
10. To analyze water quality requirements and compliance with local water quality regulations.
11. To analyze environmental and ecological impact of desalination plant installation.
12. For specific desalination plants to analyze: energy sources (generators, utility grid, solar, wind, fuel cells, hydropower, water treatment requirements)
13. To develop desalination plant financing scenarios.
14. To maintain awareness and keep abreast of desalination plant developments.
15. To keep informed of desalination plant companies worldwide.
16. To provide seminars and educational training on desalination process.
17. To develop logistics plans for desalination plants.
18. To assist in sales and contract negotiations of desalination plants
19. To formulate plans for local assembly of desalination plants.
20. To obtain exclusive representation of desalination plants and/or desalination plant components.

## ARTICLE II—ADDRESS

## ARTICLE III—DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

## ARTICLE IV—REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida are Nicholas J. Maroulis 1501 Gulf Blvd. Ste. 207 Sand Key, FL 33767.

## ARTICLE V—CAPITAL CONTRIBUTIONS

Each member of the company shall contribute to the capital of the company \$1000.

## ARTICLE VI—ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

## ARTICLE VII—ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless 51% of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

## ARTICLE VIII—MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by majority vote of all the remaining members.




ARTICLE IX—MANAGEMENT


