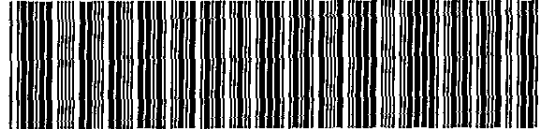

ARTICLES OF DISSOLUTION
