## Articles of Organization of DEALS, LLC

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act.

**Article I: Name.** The name of the limited liability company referred to in these Articles of Organization as "Company" is: **DEALS, LLC.**

**Article II: Duration.** The Company shall exist perpetually, beginning on the date these Articles of Organization are filed with the Florida Department of State.

**Article III: Mailing Address.** The street address of the Company's principal place of business is: 100 Executive Way, Suite 214, Ponte Vedra Beach, Florida 32082. The mailing address is the same.

**Article IV: Registered Agent and Office.** The name of the Company's initial registered agent is: **Edward W. Rahn**, and the street address of this registered agent is: 100 Executive Way, Suite 214, Ponte Vedra Beach, Florida 32082.

**Article V: Admission of New Members.** Members shall have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the members, and the members shall determine the amount and nature of contributions by each new member, at the time each new member is admitted.

**Article VI: Continuation of Company in Event of Termination of a Member, etc.** In the event of the death, retirement, expulsion, bankruptcy or dissolution of a member, or in the event of an occurrence of any other event which terminates the continued membership of a member in the Company, then the remaining members shall have the right to continue business.

**Article VII: Management of the Company.** The Company is to be managed by one or more managers. Each initial manager will serve until the first annual meeting of the members or until his successor is chosen, qualified and duly elected. The initial managers are identified as follows:

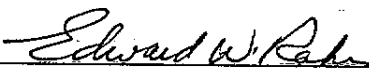

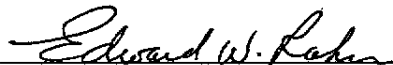
