## Articles of Organization of MERG, LLC

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act.

Article I: Name. The name of the limited liability company referred to in these Articles of Organization as "Company" is: MERG, LLC

Article II: <u>Duration</u>. The Company shall exist perpetually, beginning on the date these Articles of Organization are filed with the Florida Department of State.
