



ARTICLES OF DISSOLUTION

Pursuant to Section 608.445 of the Florida Statutes, Heart Environmental, Inc., a Florida corporation (the "Corporation") hereby files its Articles of Dissolution and states as follows:

1. The name of the Limited Liability Company is Florida Sun.Com, LLC.
2. Dissolution of the Corporation was authorized on August 15, 2008 in accordance with Fla. Stat. §441(1)(c) by the unanimous written consent of all members of the limited liability company, which totaled two, and that said members' vote and consent for dissolution was sufficient for approval of the dissolution of the limited liability company.
