ARTICLES OF ORGANIZATION
(FLORIDA)

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - Name

The name of the limited liability company shall be: Florida-Fun Rentals Unlimited, LLC.

ARTICLE II - Address

The principal place of business of the company in Florida shall be 6650 Crenshaw Dr., Orlando FL 32835 and the mailing address shall be the same.

ARTICLE III - Effective Date

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE IV - Duration
