The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be, CAFÉ ORO NEGRO, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be 999 Brickell Avenue, Suite 700, Miami, Florida 33131.

SECOND: CAFÉ ORO NEGRO, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, CAFÉ ORO NEGRO, LLC is formed are:

- (A) to engage in export/import transactions for the commercialization of coffee and other food products;


Designation and Acceptance of Registered Agent


